A standing-room-only crowd gathered Wednesday morning for the 2008 Amigos Member Conference Opening Session, where panelists Tina Lackey from the Wyoming State Library, Jenny Johnson from OCLC, and Mary Evangeliste, co-founder of the marketing company Fearless Future, discussed the importance of brand identity, targeted marketing, and tips for creating marketing campaigns geared toward a target audience. Audience members were encouraged to join in with their questions.

# **Viewpoint from the Chair**

Over the past 35 years, members have collaborated and shared their resources through Amigos' diverse programs. Collaboration through Amigos results in member discounts on a variety of supplies and electronic resources. Membership provides access to disaster preparedness and recovery services and consultation about imaging and preservation needs. Collaboration through Amigos facilitates and strengthens sub-regional and state-wide projects. It attracts federal funding

to the region. It supports a much-needed delivery service among member sites. It also provides access to continuing education on a wide variety of technical and professional topics. Do members continue to require these services? Can the Amigos cooperative continue to fund these long-standing services and develop new services that meet the needs of diverse types and sizes of libraries in the region?

Going forward, a balance between service fees and membership fees must be defined to fund the continuation of this member cooperative. The hallmark of Amigos has always been its diversity: we are a multi-state, multi-type library service cooperative. Should we retain our membership diversity and the strength it brings in terms of a broad membership base? A diverse membership requires diversity in programming, and not all members will participate in all services. The stability and continuity of the co-

operative requires a dues structure that sustains basic infrastructure services as members shift their usage (and dollars) among the various program offerings.

The Amigos Board of Trustees is forming a working group comprised of deans/directors from member libraries representative of the full membership to help define a funding structure that meets the needs of the cooperative. I am pleased to report that newly-elected Trustee Bill Hair from Baylor University Libraries will chair the Membership Structure Working Group. This Working Group will reflect the needs of our diverse membership, incorporating comments and suggestions shared by members during the May 2008 membership meeting and exploring diverse models for creating a balance between service fees and membership fees. We will convene during the first quarter of FY2009 and share recommendations with members this fall.

I have no doubt that with the diligent efforts of my fellow FY2009 Trustees, the staff of Amigos, and the continued support of members across the region, we will navigate through the issues I mention above and continue meeting the diverse needs of the membership. Thank you for providing me the opportunity to serve as Chair of the Board of Trustees through this critical transition year. And thank you for your strong participation and collaboration in the Amigos network.

# **Maricopa County Installs Potomac Messaging System**

Residents of Maricopa County (AZ) can easily stay informed about events and programs at their county library system. Maricopa County Library District's fifteen branches and one administration office work together to keep patrons up-to-date about news and events at the library with the Potomac electronic messaging system. "Patrons like it because

The Potomac, which displays full-color slides created by library staff on television or computer monitors over a secure HTTP connection, is a simple solution for libraries or library districts such as Maricopa County. And Potomac works: "Everybody who walks into our branches is stunned at the quality of dis-

play," says Vicki Terbovich, Chief Technical Officer at Maricopa County.

The high-tech, cutting-edge library system needed a way to broadcast information to patrons from a centralized source but with flexibility to accommodate needs of different user groups over a large geographic

area. Maricopa County's 4 million residents are spread over a thousand square miles, so the ability to program Potomac slides to the specific needs of sixteen individual branches or small groups of branches was crucial. Slides are programmed and controlled from the central administration office and are coordinated to run at individual branch or groups of branches,

which the system administrator creates ad hoc. "Patrons like it because they can see what's coming up," says Terbovich.

Christine Pearson, Web Developer for the library district,

controls and coordinates the slides for the entire district. Sometimes librarians send her a request for what they want a slide to look like or say, or sometimes they send her slides to upload. Pearson makes sure the design elements are consistent among all the slides so that Potomac slides system-wide have the same look and feel. Often, though, the slides vary on central themes in order to accommodate for a diverse user population. "Slides need to match the distinct flavor of each community," says Terbovich.

Once the slides are developed, Pearson orchestrates their display throughout the district from her desk at the Administration Office. She cues slides for individual libraries, groups of libraries, or for the whole system. The programming is simple, and once the slides are programmed, they run non-stop as long as the monitor in the branch library is turned on.

Maricopa County Library System chose Interface Electronic's Potomac because it was a library-specific, pre-packaged solution available through the Amigos Member Discount Program. Terbovich and Pearson are happy with their decision to purchase the Potomac, and they're hopeful for the future: "The newest iteration is to put monitors in City Hall," says Terbovich, which extends the library's reach outside the library itself. "And we hope to make better use of video soon, too."

Amigos members also approved retaining current annual member fees effective July 1, 2008. The General Member Fee is \$350 per year and the OCLC Full User Fee is \$1,100 per year. These member fees, combined with surcharges applied to members' use of OCLC products and service-specific fees related to other Amigos programs, underwrite the region's resource-sharing infrastructure provided by Amigos.

## **OCLC Members Council Update**

On May 20, the OCLC Members Council (MC) passed a resolution brought forward by the OCLC Board of Trustees to change the governance structure of OCLC. This resolution was the culmination of a governance study process that I wrote about in the March 2008 issue of QuePasa. Preceding the vote there were three sessions where the primary discussion topic was the proposed resolution.

It initially appeared that many delegates had serious concerns or reservations regarding the lack of detail in the resolution. As the discussions continued, however, there was a sense that delegates were accepting verbal reassurances about the transition process and future. Ultimately, the vote was 59 in favor of the resolution and 12 opposed.

Your delegates followed the recommendation of the Amigos Board of Trustees, and the advice from Amigos members that attended the annual Amigos Member Meeting, and voted no on the resolution. The resolution as adopted includes substantial changes to the Articles of Incorporation and Code of Regulations. The new governance structure will be comprised of: Members, Regional Councils, a Global Council and Board of Trustees.

- Members: OCLC Members are those entities that meet a minimum threshold of engagement with OCLC as defined in the Membership and Governance Protocols. A more complete definition of membership will be developed as part of the transition process. The Members will participate in meetings of their respective Regional Councils.
- Regional Councils: The purpose of the Regional Councils is to strengthen the cooperative throughout the world and make it easier to participate in its governance. Members will convene at one or more Regional Council meetings each year to keep current on issues of vital and immediate interest to the OCLC cooperative. The Regional Councils will also elect Member Delegates who will attend the Annual Global Council Meetings. Although the number of Regional Councils worldwide has consistently been described as 3-6, the number at this time remains undefined.
- Global Council: The Global Council will be comprised of Member Delegates elected by the Regional Councils. The Global Council's principal responsibilities are to elect six members of the Board of Trustees and ratify amendments to the Articles of Incorporation and Code of Regulations of OCLC. The Global Council will convene at least once a year at an annual Global Council meeting at a location to be determined by the Council.

• Board of Trustees: Under the new structure, the Board will normally have 15 trustees elected to a four-year term, but can vary in size from 13 to 17 trustees from time to time as determined by the trustees. The Global Council will elect six trustees, and the Board will elect the remaining trustees. The President and CEO will continue to hold a voting seat on the Board. Normally, a majority of the Trustees will be members of the library or cultural heritage communities. The Board of Trustees performs all of the traditional fiduciary and constituency duties related to such governing bodies.

The new Global Council will replace the Members Council in a transition that is expected to take 12-18 months and will be coordinated between representatives of the 2008-2009 Members Council and the Board of Trustees. It is expected that the newly elected Members Council Executive Committee (see www.oclc. org/us/en/news/releases/200812.htm for summary of elections) will serve as the Members Council transition team representatives.

During the transition period, the Membership and Governance Protocols will be revised to establish the structure of the Regional Council system, the definitions of membership and contribution, and to establish a method for allocation of Global Council seats to the respective regions.

Following passage of the Board of Trustees' resolution, a resolution was introduced from the floor. It reflected concerns about the current Council's power to approve or reject the new structure when the many missing details are developed over the next few months.

Throughout the 12-18 month transition period your Amigos delegation to Members Council will use this newsletter, as well as other Amigos communication channels, to keep you informed of progress and changes.
