### From the Chair & Chief Executive Officer

FY2016 was another busy year for members as they learned, shared, and saved expenses by participating in Amigos programs.

Staff from member libraries expanded their knowledge by participating in Amigos' many educational programs. Amigos hosted 26 free Know & Go sessions on 18 topics and conducted 77 fee-based training sessions for over 900 participants. Three live online topical conferences and the annual live online Amigos Member Conference resulted in collective attendance of 2,196. Members saved about \$150,000 compared to list price for these learning activities. Amigos seeks to engage additional personnel from member libraries with the reminder that our live online conferences are free to members and can be attended individually or with a group of local colleagues. The professional engagement is lively during these high-quality learning events!

The Amigos Board of Directors also expanded member benefits to include one free simultaneous-user RDA Toolkit Subscription per member library per year. These benefits save library expenses while reinforcing the collaborative commitment to sharing information and expertise, helping educate knowledge workers, and supporting library-related standards such as RDA.

Amigos members share among themselves in a variety of ways. Approximately 400 members continue to save money by participating in the long-standing Amigos Reciprocal Lending Agreement and over 250 participating libraries shipped 665,000+ items through the courier service for an estimated total savings of over \$500,000 in shipping costs.

Members benefited from 91 partnerships with leading providers of electronic databases and journals, e-books, software services, and supplies. Nine of these vendor partnerships along with ten new products were added during the year. Purchases through Amigos provided convenience as well as collective cost savings of \$5,282.294.

Our recent development of the Amigos eShelf<sup>SM</sup> Service, an e-book distribution platform that observes the principles of the ReadersFirst initiative, lays the groundwork for members to benefit in many ways. Purchasing desired e-content at reduced prices; controlling the metadata and access components of library-supplied e-content; and retaining the freedom to host with Amigos or elsewhere all represent important steps forward in the evolving e-content distribution environment. Owning rather than merely "renting" e-books is one of the great benefits of participating in this new Amigos service!

Sharing solutions as well as resources, the members of Amigos continue to deliver needed services while containing costs. Working together, members leverage collective strength to meet the needs of their local clientele. Working together, the members of Amigos continue to demonstrate that collaboration holds answers to questions we have yet to ask.

# FY2016 Highlights

#### **Member Benefits**

Amigos Members continued to benefit from strong collaborative programs. These include both direct and indirect discounts on electronic and traditional services from leading vendors; continuing education opportunities; the Amigos Job Bank, and many more. Participation in Know & Go Information Sessions continues to be an important benefit of Amigos membership.

Additional member benefits include:

- Free registration for all Amigos topical online conferences. Amigos conducted four such conferences in FY2016 with over 2,200 participants.
- Free simultaneous-user subscriptions to the American Library Association's RDA Toolkit. We cover the cost of an RDA Toolkit subscription with one single simultaneous user for each Amigos Member. We also provide discounted access to additional subscriptions for members who need multiple access points.

# Members Gaining Knowledge

Amigos Members continue to extend their knowledge of library-related processes and tools by engaging in continuing education courses offered by Amigos. Our growing course catalog lists 157 courses. During FY2016, we hosted 26 Know & Go Updates on 18 topics for 252 participants. The annual Amigos Member Conference, held May 11-12, 2016, hosted 668 attendees. Amigos staff conducted 77 fee-based training sessions for 561 participants and 1,528 participants attended our three online topical conferences held in FY2016.

# Members Maximizing Resources

Amigos Members continued to benefit from 91 partnerships with leading providers of electronic databases, electronic journals, e-books and library technologies as well as library and archival supplies and services. Members achieve cost savings and convenience when purchasing from our vendor partners. Nine new vendor partners and 12 new products were added in FY2016. New partners include: Aleph Objects, Inc., Boopsie, Business Expert Press, Country Watch, Data-Planet, Noodle Tools, Quertle LLC (Quetzel), Reprints Desk, Third Iron (BrowZine) Ten vendor partners participated as sponsors of the 2016 Amigos Member Conference: American Society of Mechanical Engineers (ASME), Artstor, Association of Computing Machinery (ACM), Boopsie, LexisNexis, Oxford University Press, Project MUSE, Quetzal, SAGE Publications, and Taylor & Frances Group.

## Members Sharing with Members

Amigos continues to ensure cost-effective borrowing and lending among libraries in two significant ways: reciprocal borrowing agreements and courier services.

Libraries that participate in one or both of Amigos' reciprocal borrowing agreements gain access to no-charge loans and copies from approximately 400 Amigos Member libraries and another 200 libraries in the Western and Midwestern U.S.

The Trans-Amigos Express (TAE) regional courier program provides low-cost shipping of library materials and inter-library loans. In FY2016, 254 TAE participants shipped more than 665,000 items through the courier service for an estimated total savings of more than \$565,000. In Texas, the courier service is known as TExpress. TExpress is a partnership between the Texas State Library and Archives Commission and Amigos that is dedicated to providing lowcost courier service to Texas libraries. Through connection agreements with the Kansas Library Express, MALA, and MOBIUS courier programs, TAE's reach extends from Arkansas, New Mexico, Oklahoma, and Texas to more than 690 libraries across Kansas, Missouri, Iowa, and Illinois.

### **Members Exploring and Reporting**

Through the Fellowship and Opportunity Award, Amigos awards up to \$10,000 each year to Amigos member libraries to fund innovative research and development projects. A key aspect of the program is sharing the experiences of members with other members. Final project reports as submitted by award recipients from previous years are posted to the Amigos website.
